The Department of Social and Cultural Sciences is a multidisciplinary department, offering four social science majors: Anthropology (ANTH), Criminology and Law Studies (CRLS), Sociology (SOC) and Social Welfare and Justice (SOWJ). A degree in any one or more of our majors equips students with a broad liberal arts perspective as well as specific skills and areas of knowledge about individual and societal behaviors, interactions and processes, values and social institutions and important socio-economic and socio-political issues of the day.

Because the social sciences are so integral to a quality education that prepares a student for a fulfilling life, many of the courses offered are approved for the Marquette Core Curriculum (<https://bulletin.marquette.edu/resources-opportunities/marquette-core-curriculum/>), which all students are required to take. Also, many of our courses are integral to several interdisciplinary majors and minors that Marquette University offers, such as Law and Society; Culture, Health and Illness; Family Studies; Africana Studies; International Affairs; Peace Studies; and Gender and Sexualities Studies.

The department also offers an internship program for any senior in one of the four majors within the department. Moreover, the department offers students the opportunity to expand their educational horizons by pursuing two majors within the department.

Note:

- A maximum of two approved courses within the department may be counted toward the completion of both majors.
- Only one course is allowed to double count between a major/minor or two minors in the department.
- ANTH 4986 Advanced Internship in Anthropology, CRLS 4986 Advanced Internship and Seminar in Criminology and Law Studies and SOC 4986 Advanced Internship and Seminar in Sociology may not be counted toward the major or minor in Anthropology, Criminology and Law Studies or Sociology. SOWJ 4986 Advanced Internship in Social Welfare and Justice may be counted toward the SOWJ major, but not the SOWJ minor.

Anthropology

ANTH 1001 Being Human (3 credits)

Introduction to four fields of anthropology (sociocultural anthropology, linguistic, biological, and archaeological anthropology). Emphasizes continuities and differences across human communities in different time periods and geographic origins, and develops anthropological methods for dismantling ethnocentrism and racism.

ANTH 1201 Introduction to Biological Anthropology (3 credits)

Explores the question of "What does it mean to be human?" from a biological perspective, while developing scientific literacy and critical thinking skills. Introductory evolutionary theory, biocultural influences and the role of sociocultural constructions of race in shaping human biology. Survey of primate diversity, ecology and behavior, with consideration of how non-human primate studies help us understand human evolution. History of fossil hominins, including evidence for the development of key anatomical and behavioral hallmarks of human uniqueness.

ANTH 2101 Cultural Anthropology (3 credits)

Introduction to theory and methods used by cultural anthropologists to compare and study human diversity across place and time. Traditional topics of kinship, culture change, navigating conflict, and coping with illness are integrated with ethnographic fieldwork and contemporary attention to power, privilege, and social justice.

ANTH 2201 Human Evolutionary Processes (3 credits)

Explores macroevolutionary and microevolutionary processes that shape the human species. Macroevolutionary processes include speciation and species concepts in primate evolution and hominin evolution, considering primate models for interpretation of hominin and modern human behavioral biology. Microevolutionary processes include a biocultural approach to considering the role of selection, mutation, gene flow, and genetic drift in human populations; and critical examination of cultural constructions of race and their impact on human biology.

ANTH 2203 Human Geography (3 credits)

Description and world distribution of landscapes with (1) an analysis of past and present interplay among land forms, biota, and human activity; (2) an investigation into the manner in which culture is both restricted and stimulated by different habitats; and (3) a critique of the ecological problems resulting from modifying the landscape. Fulfills geography requirement for social studies teaching certification.

The role of language in human life. Comparative linguistic analysis. Interdependence of language and culture.

ANTH 2401 Archaeology and Prehistoric Cultures (3 credits)

Fundamentals of archaeology, the study of past cultures through their material remains. Focuses on methods used to identify, date, interpret and conserve archaeological data. Discussion of how theory, historical developments, contemporary issues and ethical concerns shape fieldwork, laboratory analyses and cultural reconstructions.

ANTH 2501 Science, Myth and Fraud (3 credits)

Using the tools of scientific inquiry, critical reasoning, and multicultural understanding, surveys a variety of historic and modern misconceptions about past cultures. Includes how to assess claims about the past, using archeological data and interpretative tools; and apply these new standards to gain appreciation for some truly exciting recent archeological discoveries.

ANTH 3100 Urban Anthropology (3 credits)

Invites students to practice diverse anthropological research methods in Milwaukee, such as visual anthropology, material culture analysis. Emphasizes the ways in which urban culture and community produce unique configurations of work, play, health, economics and solidarity. ANTH 1001 or ANTH 2101 recommended as prerequisite but not required.

ANTH 3153 Demography (3 credits)

Methods of analyzing population structure in small-scale societies, including studies of mortality and fertility patterns in bio-social and environmental contexts.

Prerequisite: ANTH 1001.

ANTH 3250 North American Archaeology (3 credits)

Introduction to indigenous societies that inhabited what is now the continental United States, Canada and northern Mexico from the earliest settlement to first encounters with Europeans. Comparative perspective highlights the richness and diversity of this archaeological record and demonstrates how deep history is interpreted using ancient material culture and early historic documents alongside the oral histories and living traditions of Native descendant communities. ANTH 1001 or ANTH 2401 recommended as prerequisite but not required.

Cross-cultural perspective on religion in human societies. Examples from Western and non-Western societies, rituals, healing, revitalization, role of religion.

ANTH 3330 Gender and Sexuality in Cross-Cultural Perspective (3 credits)

Examination of gender and sexuality in selected societies around the world, including contemporary American society. The effects of race, ethnicity, class and other forms of vulnerability as they intersect with gender roles and gender oppression.

ANTH 3350 Native Peoples of North America (3 credits)

Ethnology of native peoples of North America: culture areas, major cultural patterns, history, and present conditions. Importance of American Indian studies to anthropological theory.

ANTH 3360 People and Cultures of the Middle East (3 credits)

Explores the variety of Middle Eastern cultures with reference to topics of central concern to cultural anthropology: environment, economics, social structure, political systems, religion, and culture change. Nomadic, rural agricultural, and urban groups are discussed. Recommended: ANTH 1001 or ANTH 2101.

ANTH 3543 Archaeology of Ancient Egypt (3 credits)

The archaeological and historic record is used to provide a survey of ancient Egyptian socio-cultural development. Emphasis is given to the interaction of economic, political and religious forces involved in state formation. The development of religious belief in Egypt is studied through surveys of iconography and an introduction to reading hieroglyphs. ANTH 1001 or cons. of instr.

ANTH 3546 Archaeology in Action: Ethnographic and Experimental Approaches (3 credits)

Introduction to the theories and methods of ethnoarchaeology and experimental archaeology. Ethnoarchaeology is the study of living groups to better understand material culture's patterns and meanings in archaeological contexts. Experimental archaeologists use replicative studies to develop hypotheses and gain insights into past technologies. ANTH 1001 or ANTH 2401 recommended as prerequisite but not required.

ANTH 3986 Internship in Anthropology (3 credits)

Field experience in a community social service agency for the purpose of furthering the student's integration of theory and practice in a professional setting. Placement is for a minimum of 140 hours per term under the supervision of agency personnel, and includes a weekly seminar with the internship coordinator. S/U grade assessment. Limited enrollment., ANTH major, and cons. of internship coordinator.

ANTH 4144 The Rise of Agriculture (3 credits)

Analyzes the process and variation in the development of farming and herding societies. Examines the archaeological record pertaining to domestication of plants and animals in North and South America, Near East, Africa and East Asia. ANTH 1001 or ANTH 2401 recommended as prerequisite but not required.

ANTH 4245 The Rise of States (3 credits)

Explores processes and variation in the early development of large-scale societies with institutionalized inequality, administrative bureaucracy and hierarchical political organization. Examines evidence of urban planning, monumental constructions, economic specialization, distinctive iconography and ideology and structured mortuary practice. ANTH 1001 or ANTH 2401 recommended as prerequisite but not required.

ANTH 4247 Bioarchaeology: Linking Bones and Behavior (3 credits)

Reconstruct patterns of human behavior from integrated biological data sets. Archaeological evidence drawn from human skeletal, plant and faunal remains. Addresses questions of nutrition, pathology, occupation and mortuary ritual.

Prerequisite: ANTH 1001 or ANTH 1201.

ANTH 4251 Human Osteology and Odontology (3 credits)

The anatomy of the skeleton and teeth. Methods of analysis of biological dynamics of past populations including reconstruction of population structure and patterns of disease.

Prerequisite: ANTH 2201.

ANTH 4252 Origins of the Human Species (3 credits)

Examines the biological past of the sapiens species. Analyzes the biological legacy of the non-human primate past and the fossils which exemplify the evolutionary trends of our species. ANTH 1201 or ANTH 2201 recommended as prerequisite but not required.

ANTH 4253 Forensic Anthropology (3 credits)

Survey of the applications of human biology in criminalistics, including forensic applications of skeletal analysis, dermatoglyphics, DNA and hair. Studies methods of handling and analyzing these evidentiary materials, as well as the probative value each has in the criminal justice system. Special emphasis on the methods of personal identification. Reviews case studies of mass disasters, human rights abuses and homicides to demonstrate the utility of techniques taught in the course.

ANTH 4255 Sex, Gender and Evolution (3 credits)

Examines the biology of sex from a comparative perspective. Considers the range of primate sexual behaviors, including reproductive anatomy, sexual behavior and sexual selection, and their relevance to understanding human sexuality. Explores human sexuality in cross-cultural perspective, including deconstruction of sex/gender binaries, examining cross-cultural constructions of gender and sexuality, and the dangers of applying eugenicist thinking to human reproduction. ANTH 1001, ANTH 1201, or ANTH 2201 recommended as prerequisite but not required.

ANTH 4316 Culture Change and Development (3 credits)

Analyzes societal changes from a holistic anthropological perspective. Recognizes factors of long-term cultural change; modernization of the West and Third World countries; ecological and social problems related to development in the contemporary world. ANTH 1001 or ANTH 2101 recommended as prerequisite but not required.

ANTH 4320 Culture, Law and Violence (3 credits)

Compares legal cultures around the globe with respect to the state's use of violence to intervene in violence. Case studies include domestic violence, sexual assault and incarceration. Focuses on theories and field methods for researching legal sites.

Prerequisite: ANTH 1001, CRLS 1001, SOCI 1001 or SOWJ 1001.

Examines the figure of the refugee in anthropological studies, forces contributing to migration and the ways in which displacement shapes the refugee life course. Familiarizes students with institutional approaches to refugee-related interventions and the challenges and ethics of migration.

Review the literature on an assigned or negotiated topic and design and propose a specific research project. Course may be repeated for credit. A maximum of six credits of ANTH 4956, 4995 and 4999 combined may be counted as electives toward the minimum requirements of the major and a maximum of three credits of ANTH 4956, 4995 and 4999 may be counted as electives toward the minimum requirements for the minor.

ANTH 4964 Archaeological Fieldwork (3 credits)

An introduction to methods used in the excavation and analysis of prehistoric sites. Surveying techniques, stratigraphy, analyses of soils and landforms, analytical fundamentals of prehistoric material remains. Summer term offering only.

CRLS 1001 Introduction to Criminology (3 credits)

Survey of recent trends in crime and delinquency. The nature of and societal reaction to criminal behavior. Personal and social factors in crime causation. Critical analysis of criminological theories as well as the operation of criminal justice agencies.
